End of Season Road Closures

As the summer/fall travel season comes to an end the following sections of the Beartooth Highway will begin to close:

Long Lake Gate just past Top of the World will close on Sunday, 10/10 at 8:00 pm. This closure will prevent travelers from driving the entire length of the Beartooth Highway.

Switchback Gates south of Red Lodge, Montana and to the Montana/Wyoming State Line will close on Friday, October 14.

Visitors will be able to travel over the Chief Joseph Highway to the western section of the Beartooth Highway and into Cooke City, Montana for several additional weeks until snow closes that section of road.
